Portsmouth Pride is NH's oldest, and largest pride celebration. 2023 marked its ninth and biggest year yet! We estimated around 10,000 people participated in the day in some, or multiple capacities. We continue to draw sponsorship and support from a wide variety of local corporations, companies, small business, and more. We are thankful for our longstanding partnership for the city of Portsmouth. In 2023, we launched our first ever Queer Arts Camp that ran for a week in the month of August. We offered before and after care making camp accessible to working families from a variety of locations on the Seacoast. Students had the opportunity to learn from teaching artists, movement activists, and more. The social bonds and connections from camp have endured through the year in other pieces of our program. We look forward to its return in 2025. Finally, we launched a new collaboration with the Portsmouth Chamber of Commerce to host a series of adult networking events co-hosted by two organizations. These events have been quickly growing, and become a highlight of the community.
