2025 was a banner year for NH Outright. We expanded from one youth group in 2024 to four total youth groups in 2025. That number continues to grow. We served over 400 young people across the state (about a 33% increase from the previous year). Community spaces for joy, safety, and support for our young people remain at the heartbeat of our work. In 2025, we trained over 1000 individuals via our outreach and education programs, and concluded a two-year program training 400 clinicians in our mental health training work. Our flagship fundraising and community event, Portsmouth Pride, broke yet another attendance record, and continued to grow. Our staff team grew to a total of five full-time employees, one part-time employee, and one seasonal position. Our staff and organization were nominated for multiple accolades, including being named the Luminary Organization of the Year by the NH Chapter of the American Foundation for Suicide Prevention.
