MANY ASPECTS OF THE LOCAL FOOD SYSTEM RELY ON ACCESS THAT THE INTERVALE FOOD HUB PROVIDES.FARMERS ACCESSING MARKETS; ADDED-VALUE PRODUCERS ACCESSING STORAGE INFRASTRUCTURE; INSTITUTIONAL BUYERS AND INDIVIDUALS ACCESSING LOCAL PRODUCT; DELIVERY NETWORKS CONNECTING WITH EACH OTHER; AND COMMUNITY MEMBERS ACCESSING FREE FOOD.
