FOREMAN EMERGENCY SHELTER AND THE TEEN PARENTING PROGRAM (TPP). SERVING INDIVIDUALS AND FAMILIES, THE TOTAL PER-NIGHT CAPACITY IS 18 ADULTS AND 26 CHILDREN. TPP SPECIALIZES IN SUPPORTS FOR PREGNANT AND PARENTING TEENS MADE HOMELESS BY FAMILY OR DOMESTIC VIOLENCE.
