THE CHAPTER NETWORK WORKS DIRECTLY WITH SCHOOL ADMINISTRATORS, EDUCATORS, STUDENTS, AND COMMUNITY PARTNERS TO DELIVER PROGRAMMING TO ADVANCE POSITIVE SCHOOL TRANSFORMATION WHERE SCHOOLS ARE AT MINIMUM SAFE AND ULTIMATELY PLACES OF LIBERATION FOR ALL YOUNG PEOPLE.
