TO MAKE EVERY VOTE COUNT, WE NEED A SYSTEM THAT IS FREE AND FAIR TO ENSURE THAT EVERYONE'S VOICE IS HEARD, INCLUDING THOSE WHO HAVE HAD CONTACT WITH THE CRIMINAL LEGAL SYSTEM. CLC BELIEVES THAT STATE AND FEDERAL POLICIES SHOULD UNIFORMLY PROTECT THE RIGHT TO VOTE AND PROMOTE VOTER PARTICIPATION ACROSS THE UNITED STATES. CLC HELPS ENACT SUCH POLICIES AT THE STATE, LOCAL AND FEDERAL LEVELS, AND WORKS TO ENSURE THAT THE FEDERAL ELECTION COMMISSION ENFORCES CURRENT CAMPAIGN FINANCE LAWS. CLC ALSO DEFENDS LAWS THAT PROMOTE THE FIRST AMENDMENT'S GUARANTEE THAT EVERY AMERICAN HAS THE ABILITY TO PARTICIPATE IN THE DEMOCRATIC PROCESS.
