THE COALITION PERFORMS TWO EMERGENCY HOUSING RELIEF PROGRAMS; HOMELESS PREVENTION, THE PAYMENT OF PAST DUE RENT/UTILITIES TO KEEP AT-RISK HOUSEHOLDS FROM BECOMING HOMELESS AND RAPID REHOUSING, THE REHOUSING OF THOSE EXPERIENCING LITERAL HOMELESSNESS.
