WE BELIEVE THAT CHANGE HAPPENS WHEN PEOPLE HAVE A REAL VOICE IN THE POLITICAL PROCESS. TO THAT END, WE MOBILIZE OUR GROWING BASE OF ACTIVISTS TO SIGN PETITIONS, MEET WITH THEIR ELECTED OFFICIALS, AND ATTEND RALLIES AND TOWN-HALL MEETINGS, TO LOBBY IN SUPPORT OF POLICIES THAT SERVE THEIR INTERESTS AND AGAINST THOSE THAT DON'T. LAUDED THE BROADBAND EQUITY, ACCESS, AND DEPLOYMENT (BEAD) PROGRAM, WHICH WILL HELP ALL 50 STATES BUILD HIGH-SPEED INTERNET NETWORKS IN COMMUNITIES THAT LACK ACCESS.
