THE PROCESS FOR DETERMINING COMPENSATION INCLUDES A REVIEW OF AVAILABLE MARKET DATA FOR COMPARABLE POSITIONS IN SIMILAR ORGANIZATIONS, INTERNAL EQUITY (EXCEPT IN THE CASE OF THE PRESIDENT, WHERE COMPARISON IS LIMITED TO THE OUTGOING PRESIDENT), AND THE CANDIDATE'S REQUESTED PAY RANGE AND PAY HISTORY. ALSO TAKEN INTO ACCOUNT ARE THE JOB FUNCTION AND RESPONSIBILITIES, INCLUDING EXPERIENCE, QUALIFICATIONS, EDUCATION, THE PAY RANGE OF THE CURRENT POSITION, AND, WHEN RELEVANT, SPECIALIZED KNOWLEDGE OF THE FIELD. COMPENSATION IS BASED ON A COMBINATION OF THESE FACTORS TO ENSURE AN APPROPRIATE PAY LEVEL. THIS PROCESS WAS LAST COMPLETED IN FY2025. SALARIES ARE REVIEWED ANNUALLY BY SENIOR MANAGEMENT AND THE BOARD OF DIRECTORS DURING THE SPRING REVIEW PROCESS. AN ANNUAL INCREASE AMOUNT IS DETERMINED BASED ON A COMBINATION OF A SALARY SURVEY CONDUCTED BY HUMAN RESOURCES OF SIMILAR ORGANIZATIONS AND THE CPI AT THE TIME OF DETERMINATION. THIS AMOUNT IS APPROVED BY THE BOARD AT THE ANNUAL MEETING AND IS AWARDED BASED ON MERIT. SUPERVISORS RECOMMEND INCREASES FOR STAFF WITH SATISFACTORY PERFORMANCE AND MAY REQUEST AN ADDITIONAL 0.5%1% INCREASE ABOVE THE STANDARD MERIT INCREASE IN WELL-SUPPORTED CASES OF EXCEPTIONAL PERFORMANCE. IN CASES OF PROMOTION OR INCREASED RESPONSIBILITIES, THE COMPENSATION DETERMINATION PROCESS DESCRIBED ABOVE IS APPLIED.
