WJC PREVIOUSLY SERVED AS CHAIR OF IJCIC AND IN OTHER OFFICIAL CAPACITIES, PARTICIPATED IN ITS INTERNATIONAL LIAISON COMMITTEE MEETING IN PARIS, FRANCE, MADRID SPAIN, AND IN WARSAW, POLAND, AMONG OTHERS, AND IN HIGH LEVEL INTERFAITH MEETINGS IN GENEVA, BRUSSELS, LONDON, AND IN THE UNITED NATIONS. THE WJC HELD A SYMPOSIUM IN WASHINGTON D.C.
