LITIGATION: IN RESPONSE TO A MYRIAD OF CIVIL RIGHTS CHALLENGES AND WITH CONTINUING ROBUST PRO BONO LAW FIRM AND COMMUNITY PARTNERSHIPS, LJP CONTINUES TO ENGAGE IN EXPANSIVE HUMAN AND CIVIL RIGHTS LITIGATION ACROSS OUR CORE ISSUE PILLARS. WE BROUGHT LEGAL CHALLENGES TO INCREASINGLY AGGRESSIVE AND HOSTILE IMMIGRATION AND LAW ENFORCEMENT POLICIES AND TACTICS, INCLUDING FORCEFULLY LITIGATING A CLASS ACTION ON BEHALF OF 674 ILLEGALLY DETAINED PERSONS HELD IN LOCAL JAIL CUSTODY BY THE SUFFOLK COUNTY SHERIFF'S OFFICE. WE CONTINUE TO LITIGATE VARIOUS CHALLENGES TO UNCONSTITUTIONAL LOCAL LAW ENFORCEMENT AND POLICING POLICIES CRIMINALIZING IMMIGRANTS. WE ACTIVELY DEFEND ACCESS TO EDUCATION IN PUBLIC SCHOOLS AND HIGHER EDUCATION ACROSS THE COUNTRY. WE CHALLENGE EXPANDED STATE AND FEDERAL VOTER SUPPRESSION EFFORTS THAT SEEK TO LIMIT ACCESS TO THE BALLOT BOX, INCLUDING AN EXECUTIVE ORDER THAT SOUGHT TO UNILATERALLY IMPOSE ADDITIONAL UNCONSTITUTIONAL CITIZENSHIP REQUIREMENTS IN ORDER TO VOTE. WE ACTIVELY CHALLENGE ALL FORMS OF RACIAL DISCRIMINATION AND OTHER CONSTITUTIONAL VIOLATIONS BY FEDERAL, STATE AND LOCAL GOVERNMENTS, AND FIGHT PRIVATE ACTORS WHO DEPRIVE OUR COMMUNITIES OF WAGES AND ACCESS TO EDUCATION.

ADVOCACY, COMMUNITY OUTREACH AND COMMUNICATIONS: WE PLAYED A CRITICAL ROLE IN SUPPORTING LEGISLATIVE ADVOCACY EFFORTS TO DRAFT AND ENACT STATE VOTING RIGHTS ACTS IN PA, NJ, MD AND FL. WE ALSO CHAMPIONED LANGUAGE ACCESS EFFORTS IN FL. OUR CRIMINAL LEGAL TEAM FOCUSED ON ENDING GANG DATABASES IN NYC AND ON PASSING YOUTH-PROTECTIVE LEGISLATION IN CA. WE ARE WORKING TO CLOSE THE SLAVERY LOOPHOLE IN THE 13TH AMENDMENT AND TO ENSURE VOTING ACCESS FOR RETURNING CITIZENS FROM INCARCERATION. WE ACTIVELY OPPOSE UNCONSTITUTIONAL IMMIGRATION ENFORCEMENT ACTIVITIES IN SEVERAL STATES. LJP ENGAGES WITH COMMUNITY-BASED IMMIGRANT RIGHTS ORGANIZATIONS TO IDENTIFY PRIORITIES ALIGNED WITH OUR CRIMINAL LEGAL AND IMMIGRANT RIGHTS WORK, INCLUDING CONDUCTING KNOW YOUR RIGHTS SEMINARS. WE CONTINUED OUR FORMERLY INCARCERATED PERSONS (FIP) ACADEMY, PROVIDING LEADERSHIP AND ADVOCACY TRAINING TO THOSE SEEKING EMPLOYMENT IN SOCIAL JUSTICE ORGANIZATIONS; WE HAVE GRADUATED NEARLY 50 INDIVIDUALS ACROSS THE COUNTRY.

LEGAL EDUCATION: OUR CAP LEADERSHIP INSTITUTE (CAP) PROVIDED CRITICAL PRE-LAW SERVICES FOR 1,425 STUDENTS ACROSS THE COUNTRY. THIS INCLUDED OVER 130 STUDENTS FOR OUR ANNUAL LAW DAY FAIR, WHICH DREW MORE THAN 80 LAW SCHOOLS AND ORGANIZATIONS; 76 STUDENTS WHO ATTENDED INTENSIVE WEEKLONG LAW SCHOOL ADMISSIONS BOOT CAMPS; TWELVE LAW STUDENTS WE PLACED IN PAID SUMMER INTERNSHIPS THROUGH OUR CORPORATE LAW FIRM ALLIANCE SUMMER PROGRAM (CLASP); AND HUNDREDS OF STUDENTS WHO ATTENDED WORKSHOPS, RECEIVED ONE-ON-ONE COUNSELING AND OTHER SERVICES. SIX CLASP FELLOWS WERE OFFERED POST-GRADUATION POSITIONS AT THEIR RESPECTIVE LAW FIRMS, CONTINUING OUR RECORD OF 100% POST-FELLOWSHIP EMPLOYMENT RATE. AND OUR LIDERES BOARD COMPRISED OF 30 YOUNG PROFESSIONAL LEADERS ACTIVELY SUPPORTED, VOLUNTEERED AND RECRUITED PEER VOLUNTEERS FOR PROGRAMS SERVING HUNDREDS OF STUDENTS PURSUING PROFESSIONAL PATHWAYS AND ALSO RAISED AWARENESS ABOUT LJP'S SOCIAL JUSTICE ADVOCACY PROGRAMS.
