FOUNDED IN 1978 AND HEADQUARTERED IN NEW YORK CITY, SAGE IS A NATIONAL ORGANIZATION THAT OFFERS SUPPORTIVE SERVICES AND RESOURCES FOR LGBT OLDER ADULTS AND THEIR CAREGIVERS, ADVOCATES FOR PUBLIC POLICY CHANGES THAT ADDRESS THE NEEDS OF LGBT OLDER PEOPLE AND PROVIDES TRAINING FOR LGBT ORGANIZATIONS AND AGENCIES PROVIDING SERVICES TO OLDER ADULTS, LARGELY THROUGH SAGECARE AND ITS NATIONAL RESOURCE CENTER ON LGBT AGING.
