Corps Members - TFA recruits, selects, trains and develops exceptional leaders to teach the nation's most underserved students. The organization hosts on and off campus recruitment events, networks and cultivates relationships with prospects and communities in order to recruit exceptional leaders. The organization then processes applications and conducts interviews to select corps members, placing them in various urban and rural regions throughout the United States. Corps members are supported financially, and engage in intensive virtual, hybrid, and in-person training where they have the opportunity to understand their role and work, build community with one another, learn practical skills, and apply their learning in preparation for their first day of school. Corps members are then supported throughout a two-year classroom experience with additional coaching and instructional supports as well as leadership and/or educator professional development.

Systems Change - TFA recognizes that significant progress in education can only be achieved with extraordinary actions and partnerships within the communities in which we work. Investing in work that allows learning of new capabilities and experimentation with innovative practices to bring forth a reinvention of the existing school models.
