HSC TACKLES CROSS-SECTOR ISSUES AND WORKS WITH PARTNERS IN GOVERNMENT, PHILANTHROPY, ACADEMIA, MEDIA, AND OTHER NONPROFITS TO ENSURE THE CONCERNS OF NEW YORK’S HUMAN SERVICES SECTOR AND ITS CONSTITUENTS ARE HEARD. WE ADVOCATE ON BEHALF OF OUR ALMOST 200 MEMBERS, WHICH PROVIDE HUMAN SERVICES FOR NEW YORKERS. SOME ADVOCACY ACCOMPLISHMENTS AND CAMPAIGNS INCLUDE:1. JUSTPAY CAMPAIGN WHICH FIGHTS FOR FAIR, LIVABLE, AND PROGRESSIVE PAY FOR THE HUMAN SERVICES WORKFORCE. SINCE ITS LAUNCH, THE JUSTPAY CAMPAIGN HAS GROWN INTO A GRASSROOTS MOVEMENT OF OVER 6,000 ADVOCATES ACROSS NEW YORK FIGHTING FOR FUNDING AND SYSTEMIC POLICIES TO ENSURE HUMAN SERVICES WORKERS RECEIVE LIVABLE WAGES.
