AFTER 15 YEARS OF DEVELOPMENT SINCE THE ESTABLISHMENT OF THIS PROGRAM, WITH THE ACTIVE SUPPORT OF TOP 18 UNIVERSITIES IN CHINA, C100 SCHOLARS PROGRAM HAS AWARDED OVER 400 SCHOLARS OVER THE YEARS. CANDIDATES ARE TOP STUDENTS WHO HAVE DEMONSTRATED THEIR LEADERSHIP IN THE FIELDS OF SOCIAL SERVICES, INNOVATION & ENTREPRENEURSHIP, AND U.S.-CHINA RELATIONS.
