ON SEPTEMBER 24, 2010, THE COMMITTEE CHANGED ITS NAME TO THE INSTITUTE FOR GLOBAL LABOUR AND HUMAN RIGHTS, INC. THROUGH LONGSTANDING RELATIONSHIPS WITH HUMAN WOMENS AND LABOR RIGHTS NGOS IN THE DEVELOPING WORLD, THE INSTITUTE SUPPORTS WORKERS' EFFORTS TO LEARN AND WIN THEIR RIGHTS, WHILE DOCUMENTING WORKING CONDITIONS AND ABUSES IN PRODUCTION DESTINED FOR THE U S AND EUROPE AND PROVIDING VALUABLE INFORMATION FOR U S CITIZENS AND POLICY MAKERS. THE INSTITUTE'S DIRECT RESEARCH, REPORTS, WEB RESOURCES AND VIDEOS COMBINING CASE STUDIES WITH ECONOMIC DATA, TRADE STATISTICS, INFORMATION ON PUBLIC POLICY AND THE PRACTICES OF U S AND EUROPEAN UNION. MULTINATIONAL CORPORATIONS SOURCING PRODUCTION IN POOR, DEVELOPING COUNTRIES HAVE BECOME AN IMPORTANT RESOURCE FOR MEMBERS OF CONGRESS AND OTHER POLICY-MAKERS, LABOR AND RELIGIOUS LEADERS AND THE PRESS.
