THE COLLECTIVE, OUR SIGNATURE LEADERSHIP ADVANCEMENT PROGRAM, HAS TRAINED, SUPPORTED, AND CONNECTED 50 JEWISH WOMEN EXECUTIVES WORKING FOR SOCIAL CHANGE. AS A PARTICIPANT IN THE PROGRAM THEY PARTICIPATE IN ELLUMINATE PROVIDES A TWO-YEAR CURRICULUM FOCUSED ON LEADING THROUGH A JEWISH AND GENDER LENS, COHORT GROUP, BUILD PEER-TO-PEER RELATIONSHIPS BUILDING, CAPACITY GRANTS FOR THEIR ORGANIZATIONS, AND INDIVIDUAL PROFESSIONAL DEVELOPMENT TRAINING ,THEY ALSO BECOME PART OF THE ELLUMINATE NETWORK AND GET A NATIONAL PLATFORM(CONTINUED ON SCHEDULE O)(CONTINUED)FOR THEIR CAUSE INCLUDING A DEDICATED WEBINAR CALLED CROWN JEWEL CONVERSATIONS.
