Episcopal Charities (EC) is a community of 100 outreach programs serving communities in New York City and the Hudson Valley. EC provides grant funding and operational supports exclusively to non-sectarian partner programs located at parishes around the Episcopal Diocese of New York. In recent years, EC has developed and scaled innovative programs that maximize food access to the food insecure of the area.

Through its grant programs, Episcopal Charities offers support for basic human needs programs and youth opportunity programs. Basic Human Needs grants are awarded to programs which include: food pantries and community kitchens, skill-building programs for those re/entering the workforce including recent immigrants and the formerly incarcerated reentering society, and health and wellness programs that improve quality of life for senior citizens, the homebound and people in recovery. Youth Opportunity Grants support programs which include: children's arts programs, academic enrichment and summer recreations programs.

Episcopal Charities (EC) set up an emergency relief fund in spring of 2020 and continuing through 2021, to meet partner program's changing programmatic funding needs in real-time as a result of the pandemic. In response to those immediate needs, and utilizing emergency funds raised, Episcopal Charities (EC) launched two new innovative programs to address rising food insecurity - Bulk Buy and Farm to Pantry - as demand at EC's 62 food access program partners increased dramatically. The Bulk Buy program was created to enable food pantry partners to purchase culturally relevant foods their communities need at a reduced price that EC pre-negotiates with food wholesalers. Farm to Pantry met the need for reducing supply chain exposure and for pantries to provide nutritious fresh foods they do not receive from food banks. EC contracts with local farmers to grow vegetables individual programs need for their unique communities at a similar cost to purchasing wholesale.
