CULTURE & COMMUNITY CENTERS - CULTURAL ACTIVITIES OFTEN TAKE PLACE AT FEDERATION-SPONSORED JEWISH COMMUNITY CENTERS. A SUCCESSFUL JCC IS A SECOND HOME, WHERE JEWS OF ALL AFFILIATIONS AND AGES JOIN EDUCATIONAL AND MANY OTHER ACTIVITIES IN A NURTURING COMMUNAL SETTING. JCCS HOST WOMEN'S CLUBS, SPORTS CLUBS, BOOK CLUBS, CHESS CLUBS, SINGLES' CLUBS, FAMILY CLUBS, BUSINESS CLUBS, AND YIDDISH CLUBS. THEY OFFER HEBREW CLASSES AND DISCUSSION GROUPS ON JEWISH TOPICS, SUCH AS TALMUD, KABBALAH, MEDICAL ETHICS, AND FAMILY LAW. THE JCCS ALSO SERVE AS INFORMATION AND EDUCATION CENTERS, INCLUDING ARRANGING HOLIDAY EVENTS AND LIFE CYCLE CEREMONIES. IN MANY COMMUNITIES THEY ARE THE SOLE SUPPLIER OF JUDAICA. THE FEDERATION CURRENTLY SUPPORTS MORE THAN 100 COMMUNITY CENTERS ACROSS THE FORMER SOVIET UNION. ITS GOAL IS TO OPEN A JCC IN EVERY CITY AND TOWN WITH A SUBSTANTIAL JEWISH POPULATION, EACH WITH ITS OWN FITNESS CENTER, MULTI-FUNCTION HALLS AND CLASSROOMS, THEATER, LIBRARY, SOUP KITCHEN, AND EVEN MEDICAL FACILITIES. THE FEDERATION ALSO HELPS REBUILD SYNAGOGUES AND MIKVAS, REFURBISHES CEMETERIES AND ASSISTS THE NEEDY. THROUGH A STRATEGIC PARTNERSHIP WITH CHABAD LUBAVITCH, THE FEDERATION SUPPORTS MORE THAN 200 PERMANENT RABBIS SERVING OVER 90 COMMUNITIES IN 15 COUNTRIES. MANY RABBIS SERVE IN REMOTE LOCATIONS AND INHOSPITABLE CLIMATES. IN ADDITION TO LEADING PRAYER SERVICES AND PERFORMING WEDDINGS, BAR AND BAT MITZVAHS AND FUNERALS, THEY PARTNER WITH LOCAL JEWISH LEADERS IN REBUILDING THE ENTIRE COMMUNITY INFRASTRUCTURE AND LEADING THE REMARKABLE REVIVAL OF JEWISH LIFE THROUGHOUT THE FORMER SOVIET UNION.
