AT THE END OF FY 2022, HFLS HAD 3,032 LOANS OUTSTANDING, TOTALING \$25.3 MILLION. IN FY22 ALONE, HFLS DISBURSED MORE THAN \$24,2 MILLION TO AID 1,625 INDIVIDUALS AND FAMILIES IN THE NEW YORK METROPOLITAN AREA.
