(C)THE THIRD CLASS OF MEMBERSHIP IS THE SUSTAINING MEMBERSHIP. SUSTAINING MEMBERSHIP SHALL BE OPEN TO ANY PERSON WHO HAS BEEN RETRENCHED OR NON-RENEWED OR WHO HAS BEEN INVOLUNTARILY TERMINATED FOR ANY REASON AND HAS LITIGATION, GRIEVANCE, OR OTHER, SIMILAR PROCEEDINGS IN PROGRESS. SUSTAINING MEMBERSHIP TERMINATES UPON REINSTATEMENT IN THE NEGOTIATING UNIT OR RESOLUTION OF SUCH LITIGATION OR OTHER PROCEEDINGS, AND IS LIMITED TO THE PERIOD OF LITIGATION OR A THREE-YEAR TERM, WHICHEVER IS LONGER. NY STATE IS AN UNRELATED PARTY TO UUP; HOWEVER, SINCE UUP REIMBURSES NY STATE FOR THE ENTIRE SUNY SALARY, THE SUNY SALARY IS TREATED AS HAVING BEEN PAID BY UUP FOR 990 PURPOSES.
