Maryland Justice Reform - JPI continued to provide research and policy support for justice reform initiatives to reduce Marylands reliance on prison and advance parole reforms. JPI published Safe at Home: Improving Marylands Parole Release Decision Making. JPI supported various coalitions to advance reform initiatives and building strategic partnerships and relationships to enhance justice reform work in Maryland. JPI also served as a fiscal sponsor for the Maryland Prisoner Rights Coalition as they worked on decarceration efforts in Maryland.

Youth Justice Reform and Crime Survivor Work - Engaged in research, communications, and coalition activities to support youth justice reform work, including research and analysis to examine community and crime survivor responses for youth charged with violence. As part of this work JPI released the report Youth Justice in COVID-19 Pandemic: Lessons From Five Sites and the short film and brief Dont Abandon Us: Addressing Youth, Crime, and Trauma. JPI also served as a project partner and convenor of the Public Information Officers Learning Collaborative in partnership with the Georgetown University Center for Juvenile Justice Reform, providing support to youth justice and child welfare PIOs from across the country.

IRAA Implementation Support Support to District-wide efforts to build a comprehensive response to the needs of those released under the Incarceration Reduction Amendment Act of 2016 (IRAA) and the Second Look Act of 2020, including providing coordination among funded legal services and reentry service providers.

Emerging Adult Justice Reform Work in Washington, DC JPI worked in coalition with partner organizations and advocates related to advancing implementation of the Emerging Adult Strategic Plan (18-to-24-year-olds) as required under the Amended Youth Rehabilitation Act of 2018. As part of this work JPI coordinated local advocates, criminal justice reform experts, and justice-system impact community members to help identify priority areas the District should focus on to enhance responses for justice involved emerging adults. In addition, JPI published the emerging adult persona cards and the brief Missed Opportunities: Why Inaction on Prevention Measures Undermines Public Safety in Washington, DC, as well as participated in the Columbia University Emerging Adult Justice Projects innovation site cohort.
