Justice Reform efforts in DC, Maryland and Virginia - JPI continued to provide research and policy support for justice reform initiatives in DC, Maryland, and Virginia. JPI supported various coalitions to advance reform initiatives and building strategic partnerships and relationships to enhance justice reform in the region. JPI worked on various policy issues including parole reform, second look, higher education in prison, community investment, electronic monitoring, and youth justice. JPI also published The Right Investment 2.0: How Maryland can Create Safe and Healthy Communities.

As part of this work JPI published the report Building a Brighter Future: A Plan to Invest in DCs Emerging Adults, as well as participated in the Columbia University Emerging Adult Justice Projects innovation site cohort.
