Part III Program Service Accomplishments:During 2020, despite disruptions incurred by the COVID-19 pandemic, the America's Agenda Healthcare Education Fund (AAHEF or the Fund) succeeded in building on earlier educational, research, analysis, and policy development program activities to advance of our mission of making access to high quality health care affordable for all Americans. The Funds principal 2020 program attitiies focused in the following three areas:1.Redesign of Public Sector Healthcare Delivery During 2020, confronting the COVID-19 pandemic, the Fund re-examined the focus of our work on the Governors Taskforce on Health Benefits Quality and Value in the State of New Jersey The Task Force launched its work in 2019, with the objective of publishing a blueprint for the healthcare delivery and payment system for a public employee health care plan that provides health benefits to approximately 750,000 state, local government, and public school employees, and their dependents, and the Fund became engaged with New Jersey Governor Phil Murphys appointment of the Funds Managing Director Mark Blum to the Task Force. In summer 2020, he joined other Task Force members in calling for a review of the Task Forces emerging blueprint,t as the the COVID-19 pandemic revealed serious challenges to public health, which had devastating impact on the residents and public employees of the state, and placed stress on the states health care delivery system not seen since the Spanish flu epidemic 100 years earlier. The Fund provided support to review and refocusing of the Task Force blueprint over the course of 2020.2.Structuring Dynamically Competitive PBM Marketplaces to Reduce Cost of Prescription Medicines - AAHEF developed a hypothesis for how creation of dynamic competition in the PBM marketplace could capture significant savings to State employee health plans purchasers of prescription drugs. The hypothesis was tested successfully with New jersey's implementation of AAHEF-designed strategy in two successive PBM reverse auctions conducted in 2017 and 2019 that together captured \$2.52 billion dollars in prescription savings for the state. During 2020, the AAHEFs Labor & Employer Healthcare Tranformation Project (LEHTP), developed educational materials about the AAHEF-developed policy and presented policy briefings strategy on a non-partisan basis to senior members of state governors staffs, state legislators and their staffs, and a variety of state stakeholder organizations in in Maryland and New Hampshire, among other states. LEHTP educational materials focus on common-sense principals framed non-ideologically as common-ground, bipartisan policy solutions to create dynamically competitive PBM marketplaces that will drive significant savings to self-funded State health plans and their beneficiaries -- and ultimately, to taxpayers -- without requiring cuts in prescription benefits for public employees. During the course of 2020, Maryland enacted The Maryland Competitive Pharmacy Benefits Manager Marketplace Act and New Hampshire enacted The New Hampshire Prescription Drug Marketplace Act, each with overwhelming bipartisan majorities to implement the AAHEF-designed strategy for creation of dynamically competitive PBM marketplaces. 3.Public Education - During the course of 2020, AAHEF has continued our research and public educational activities with regard to high-value care delivery design and the lessons learned from the implementation of AAHEF-articulated care delivery design principles in both public and private sector settings. Due to restricted travel and in-person meetings during the COVID-19 pandemic, the Funds Labor and Employer Healthcare Transformation Project (LEHTP) pivoted substantially to online training and education, including interactive, online seminars for employers and labor union representatives and dissemination of information about these programs over social media channels. As an illustration of online training during the COVID-19 pandemic, AAHEF partnered with Kaiser-Permanente in summer 2020 to host an online seminar for employers and union representatives across the country entitled: Planning for the New Normal at Work: Keeping your workplace safe and healthy.As another illustration of our online educational work, Americas Agenda formed a working group with medical provider partners to develop an innovative, pilot program design for delivery of high-value pain management/musculoskeletal care, which is a source of significant, unmanaged health care cost. Our pilot program will offer potential for significant savings on muscular-skeletal care, more predictable management of health plan costs, and better patient care outcomes. An educational slide deck, entitled Musculokeletal Pilot Program, was developed to support online education about the innovation pilot for policy-makers and officers of union and employer health plans.

AAHEF easily meets this requirement. Its public support is well over ten percent, with a support percentage of nearly 29% for 2020 and 2019.Attraction of public support. AAHEF maintains an ongoing program of soliciting funds from a wide array of organizations. These have included unions, corporations, charities, and associations. In addition to nine member organizations which provided financial support in 2020, AAHEF received charitable donations that support its state-level activities. Over the five-year public support testing period, AAHEF has received support from sixteen organizations and individuals. Its ongoing fundraising activities are reflected in the fact that over eight percent of its annual expenditures are for fundraising. Facts and Circumstances Test Other FactorsPercentage of Public SupportAAHEFs actual level of public support is close to the 33 1/3% requirement of the strict mathematical test, at 28.85% for 2020. Its supporters are an array of different institutions that represent diverse segments of the public -- national and international labor unions, businesses, and health care providers.
