AAHEF EDUCATED SELF-FUNDED HEALTH PLAN TRUSTEES ABOUT BETTER HEALTH OUTCOMES AND PROLONGUED LIFE EXPECTANCY WITH TRANSPLANTATION AND POTENTIAL OF CAPTURING SIGNIFICANT SAVINGS BY REDUCING NET COST OF CARE WITH TRANSPLATNTATION COMPARED TO COST OF PROLONGED PATIENT RELIANCE ON DIALYSIS. LEHTP HAS RECOMMENDED A FOLLOW-UP INITIATIVE TO IDENTIFY POTENTIAL KIDNEY DISEASE PATIENTS EARLIER THROUGH AUTOMATED POPULATION HEALTH CLAIMS DATA REVIEW AND ENGAGE PATIENTS AT RISK OF ESRD EARLIER IN THE DISEASE TRAJECTORY WHEN THEY ARE RELATIVELY MORE HEALTHY, HEALTH OUTCOMES ARE PROSPECTIVELY BETTER, AND OVERALL HEALTH COST SAVINGS TO THE SELF-FUNDED UNION AND EMPLOYER TRUST ARE EVEN GREATER. PLANS ARE UNDERWAY TO IMPLEMENT THE EXPANDED LEHTP RECOMMENDATION IN 2025.
