THE DATABASE AGGREGATES PUBLIC INFORMATION ON OVER 396,000 INFLUENTIAL INDIVIDUALS AND INSTITUTIONS, RANGING FROM PUBLIC OFFICIALS TO LARGE CORPORATIONS, AND OVER 1,600,000 RELATIONSHIPS AMONG THEM, RANGING FROM EMPLOYMENT RELATIONSHIPS TO CAMPAIGN CONTRIBUTIONS. VOLUNTEER EDITORS CONTRIBUTE WELL-SOURCED DATA TO LITTLESIS AND BUILD MAPS OF POWER NETWORKS. IN 2020-2021, LITTLESIS DATA EXPANDED SIGNIFICANTLY, WITH OVER 89,793 NEW ENTITIES ADDED TO THE DATABASE.
