THE DATABASE AGGREGATES PUBLIC INFORMATION ON OVER 407,000 INFLUENTIAL INDIVIDUALS AND INSTITUTIONS, RANGING FROM PUBLIC OFFICIALS TO LARGE CORPORATIONS, AND NEARLY 1,700,000 RELATIONSHIPS AMONG THEM, RANGING FROM EMPLOYMENT RELATIONSHIPS TO CAMPAIGN CONTRIBUTIONS. VOLUNTEER EDITORS CONTRIBUTE WELL-COURSE DATA TO LITTLESIS AND BUILD MAPS OF POWER NETWORKS USING OUR DATA VISUALIZATION TOOLS.
