THROUGH A HOLISTIC APPROACH TO MOVEMENT SUPPORT FOUNDATION REGRANTING, SPECIAL INTEREST/COMMUNITY ADVISED FUNDS, AN EQUITABLE DAF, CAPACITY BUILDING, STORYTELLING AND COMMUNICATIONS, STRATEGIC THOUGHT PARTNERSHIP, FISCALLY SPONSORED PROJECTS (FSPPS) - WE CHALLENGE UNJUST SYSTEMS, PROVIDING SPACE FOR EXPERIMENTATION, INCUBATION, AND TRANSFORMATION TO TRANSFORMATIVE MOVEMENT LEADERS TACKLING SOCIAL JUSTICE CAUSES THAT CENTER ON THE INTERCONNECTED ISSUES OF RACIAL, GENDER, ECONOMIC, AND ENVIRONMENTAL INEQUITIES. (SEE SCHEDULE O FOR CONTINUATION)OUR STAFF REFLECTS THE RICH DIVERSITY AND LIVED EXPERIENCE OF OUR PARTNER COMMUNITIES; THE MAJORITY OF OUR BOARD MEMBERS ARE ALSO LEADING FRONTLINE MOVEMENT WORK AND HAVE DIRECT INSIGHT AND KNOWLEDGE OF THE SPACE. WE INSIST ON A RADICAL SHIFT IN PHILANTHROPY THAT TRANSFORMS GIVING PRACTICES AND POWER DYNAMICS IN SUPPORT OF A CULTURE OF MUTUAL SUPPORT AND REGENERATION, ENABLING A JUST TRANSITION.OUR MOVEMENT INFRASTRUCTURE AND INNOVATION CENTER (MIIC) PROVIDES TRANSFORMATIONAL SERVICES ACCELERATING THE VISIONS OF OUR ECOSYSTEM PARTNERS, INCLUDING OUR PORTFOLIO OF FISCALLY SPONSORED PROJECTS (FSPPS). WE EMBODY THE VALUES AND PHILOSOPHIES OF OUR FRONTLINE PARTNERS AND CARRY THE FISCAL, LEGAL, AND COMPLIANCE RISKS AND RESPONSIBILITIES, SO THEY CAN FOCUS ON THEIR IMPORTANT WORLD CHANGING WORK. MIIC ALSO HOLDS OUR DESIGN, INNOVATION, AND CONSULTING WORK TO EMBED TRANSFORMATIVE MOVEMENT PRACTICES THROUGHOUT OUR ECOSYSTEM.OUR MOVEMENT STRATEGY NETWORK (MSN) PARTNERS - WHO FOSTER THE TRANSFORMATIVE MOVEMENT ETHOS WITH WHICH WE WERE FOUNDED - SEED A LARGER MOVEMENT AND ACTIVIST ECOSYSTEM OF COLLABORATION AND CROSS-POLLINATION. MSN MEMBERS SHARE A DEDICATION TO MOVEMENT BUILDING, BELOVED COMMUNITY, AND ARE WORKING TOWARDS THE 100 YEAR VISION. MSC ALLOCATES APPROXIMATELY \$1.5M PER YEAR OF OUR UNRESTRICTED FUNDS TO MSN PARTNERS TO ENSURE THIS IMPORTANT WORK CAN CONTINUE TO FLOURISH.OUR REGRANTING SERVICES CENTER EQUITY, EXPAND ACCESS TO RESOURCES, AND SHIFT POWER FROM WEALTHY INDIVIDUALS, FOUNDATIONS, AND CORPORATIONS TO FRONTLINE MOVEMENT LEADERS, WHILE REDESIGNING EXTRACTIVE SYSTEMS, EDUCATING PHILANTHROPY, AND ADVANCING COMMUNITY-DRIVEN WEALTH-BUILDING STRATEGIES TOWARD EQUITY, JUSTICE, AND SOVEREIGNTY. WE CURRENTLY MANAGE APPROXIMATELY \$15M A YEAR IN GRANTMAKING FOR PHILANTHROPY.OUR SPECIAL INTEREST FUND (SIF)/COMMUNITY ADVISED FUND PROGRAM WAS CREATED TO ADDRESS THE GROWING NEED TO SUPPORT FRONTLINE COMMUNITIES AND GROUPS WHO ARE LIMITED IN HOW THEY CAN ACCESS RESOURCES FROM PHILANTHROPY. WE ALSO ESTABLISH PARTICIPATORY GRANTMAKING MODELS THAT SHIFT POWER FROM WEALTHY DONORS AND CENTER COMMUNITY LEADERSHIP. OUR DONOR ADVISED FUND (DAF) PROGRAM ENGAGES INDIVIDUALS INTERESTED IN MOVING FROM BYSTANDER TO ACTIVIST BY ACTIVATING THEIR RESOURCES TO MAKE AN IMPACT. BUT, OUR'S IS ROOTED IN OUR DEEP COMMITMENT TO MISSION-ALIGNED FRONTLINE GROUPS ADVANCING EQUITY, JUSTICE, AND SOVEREIGNTY PRIORITIES AND DETERS WEALTH HOARDING.OUR ROLE IN THE EQUITABLE INTERMEDIARY FUND COHORT SUPPORTS DEVELOPMENT OF EDUCATIONAL RESOURCES AND TOOLS TO PRIORITIZE EQUITY IN THE INTERMEDIARY SPACE. AS AN "EQUITABLE" INTERMEDIARY" WE ARE PART OF A VERY SMALL AND RARE BREED OF INTERMEDIARIES, AND WHAT IT MEANS TO BE AN EQUITABLE INTERMEDIARY IS THAT BEYOND THE BASIC TRANSACTIONAL FINANCIAL, COMPLIANCE, HR ADMIN SERVICES THAT MOST INTERMEDIARIES PROVIDE, WE ALSO PROVIDE TRANSFORMATIONAL ASSISTANCE TO OUR VALUES ALIGNED FISCALLY SPONSORED PROJECTS.OUR AFFILIATED 501(C)(4) ACTION FUND WAS RELAUNCHED TO PROVIDE OUR GRASSROOTS PARTNERS WITH THE FOUNDATION TO DEEPEN THEIR DEMOCRACY INITIATIVES.

THE ORGANIZATIONS BYLAWS WERE RESTATED IN JANUARY OF 2023, AND REFLECT THE FOLLOWING CHANGES: - PURPOSES (SECTION 2.1) THE CURRENT BYLAWS CONTAIN THE SPECIFIC PURPOSE STATEMENT FROM THE ARTICLES, AS DESCRIBED ABOVE. IF AND WHEN MSC RESTATES ITS ARTICLES OF INCORPORATION, IT WILL BE ABLE TO MODIFY ITS MORE SPECIFIC PURPOSE STATEMENT IN ITS BYLAWS. WE HAVE INCLUDED A MODIFIED SPECIFIC PURPOSE STATEMENT IN THE BYLAWS IN ANTICIPATION OF THE ARTICLES BEING RESTATED. - NON-VOTING MEMBERS (SECTION 3.2) THE CURRENT BYLAWS STATE THAT MSC HAS ONE CLASS OF NON-VOTING MEMBERS CONSISTING OF PERSONS WHO HAVE MADE DONATIONS TO MSC. WHILE MSC IS PERMITTED TO CREATE CLASSES OF NON-VOTING MEMBERS AS IT WISHES, TO GIVE THE ORGANIZATION MORE FLEXIBILITY, WE HAVE DELETED THIS LANGUAGE FROM THE RESTATED BYLAWS. - CONSECUTIVE TERM LIMITS (SECTION 4.4) THE RESTATED BYLAWS CONTINUE TO PROVIDE THAT DIRECTORS WILL SERVE FOR TWO (2) YEAR TERMS. HOWEVER, WE HAVE ADDED LANGUAGE PROVIDING THAT NO DIRECTOR MAY SERVE MORE THAN FIVE (5) CONSECUTIVE TERMS, WITH A TERM OF LESS THAN ONE (1) YEAR NOT COUNTING TOWARDS THE CONSECUTIVE TERM LIMIT. - REMOVAL OF A DIRECTOR (SECTION 4.7(C)) THE CURRENT BYLAWS PROVIDE THAT A DIRECTOR MAY BE REMOVED WITH CAUSE BY A VOTE OF A MAJORITY OF THE DIRECTORS THEN IN OFFICE, BUT ARE SILENT AS TO REMOVAL WITHOUT CAUSE. IN ORDER TO PROVIDE FOR GREATER FLEXIBILITY, THE DRAFT RESTATED BYLAWS PROVIDE THAT A DIRECTOR MAY BE REMOVED, WITH OR WITHOUT CAUSE, BY THE VOTE OF THE MAJORITY OF THE DIRECTORS THEN IN OFFICE. - APPROVAL OF EXECUTIVE COMPENSATION (SECTION 4.10) THE DRAFT RESTATED BYLAWS INCLUDE A REMINDER, NOT INCLUDED IN THE CURRENT BYLAWS, OF MSC'S OBLIGATION UNDER THE NONPROFIT INTEGRITY ACT TO APPROVE THE COMPENSATION RECEIVED BY CERTAIN OFFICERS. - QUORUM (SECTION 5.5) THE CURRENT BYLAWS PROVIDE THAT A QUORUM IS FIFTY PERCENT (50%) PLUS ONE (1) DIRECTOR. IN ORDER TO BETTER PLAN FOR AN ODD NUMBER OF DIRECTORS, THE DRAFT RESTATED BYLAWS PROVIDE THAT A QUORUM CONSISTS OF A MAJORITY OF THE NUMBER OF DIRECTORS THEN IN OFFICE. - BOARD COMMITTEES AND ADVISORY COMMITTEES (SECTIONS 6.1 AND 6.3) THE DRAFT RESTATED BYLAWS CLARIFY THE DISTINCTION BETWEEN BOARD COMMITTEES (WHICH MAY ACT WITH THE FULL AUTHORITY OF THE BOARD, BUT MAY ONLY BE COMPOSED OF DIRECTORS) AND ADVISORY OR OTHER COMMITTEES (WHICH MAY BE DELEGATED WITH SPECIFIC AUTHORITY, BUT MAY NOT ACT ON BEHALF OF THE BOARD, AND MAY INCLUDE DIRECTORS AND NON-DIRECTORS). - OFFICERS (SECTION 7.1) THE CURRENT BYLAWS PROVIDE THAT MSC MUST HAVE A PRESIDENT, SECRETARY, AND TREASURER AND FURTHER STATE THAT THE PRESIDENT IS THE CEO OF MSC. TO MORE ACCURATELY REFLECT MSC'S CURRENT OFFICER STRUCTURE, THE DRAFT RESTATED BYLAWS STATE THAT MSC MUST HAVE A CHAIR OF THE BOARD, EXECUTIVE DIRECTOR, SECRETARY, AND TREASURER, AND THAT THE EXECUTIVE DIRECTOR IS THE CEO OF THE ORGANIZATION. - TERMS FOR ELECTED OFFICERS (SECTION 7.2) THE CURRENT BYLAWS DO NOT SPECIFY A TERM LENGTH FOR ELECTED OFFICERS. IN THE DRAFT RESTATED BYLAWS, WE HAVE INCLUDED A TERM OF TWO (2) YEARS FOR ALL ELECTED OFFICERS OF MSC. - CFO OFFICER POSITION (SECTION 7.12) WE ALSO ADDED A DESCRIPTION FOR AN OPTIONAL CFO, IN ADDITION TO A TREASURER, IN CASE MSC WOULD LIKE FOR A STAFF MEMBER TO SERVE AS CFO AND A DIRECTOR TO SERVE AS TREASURER. - INDEMNIFICATION (ARTICLE VIII) THE PROVISIONS REGARDING INDEMNIFICATION IN THE DRAFT RESTATED BYLAWS HAVE BEEN EXPANDED TO TRACK WHAT IS REQUIRED OF THE ORGANIZATION UNDER THE LAW. THESE ADDITIONAL PROVISIONS DO NOT REFLECT A CHANGE IN REQUIREMENTS FOR MSC. WE GENERALLY RECOMMEND INCLUDING THESE PROVISIONS IN FULL IN BYLAWS BECAUSE IT MAKES THEM A MUCH MORE USEFUL REFERENCE TOOL, PARTICULARLY SINCE FEW ORGANIZATIONS REGULARLY CHECK THE PROVISIONS OF THE LAW. - AUDIT AND AUDIT COMMITTEE REQUIREMENTS (SECTIONS 6.4 AND 9.9) WE HAVE ADDED PROVISIONS TO THE DRAFT RESTATED BYLAWS REGARDING THE NONPROFIT INTEGRITY ACT REQUIREMENTS THAT THE ORGANIZATION HAVE AN EXTERNAL FINANCIAL AUDIT AND AN AUDIT COMMITTEE UNDER CERTAIN CIRCUMSTANCES.
