The USHRN National Biennial Conference was held in Atlanta, GA in December 2017. The conference brought together over 150 groups to raise awareness on a range of social issues and to build the human rights capacity of different community leaders. The conference participants collaborated in strategy sessions to advance human rights in the current context of the United States, both through engagement at the international level and implementation here at home. The conference also successfully introduced participants to skills building workshops, as well as raised awareness about issues related to economic and social rights, cultural rights, black girls and women in the rural south, and human rights violations against Indigenous peoples, refugees, and migrants.

The Network coordinated a meeting between members of U.S. civil society and the UN High Commissioner on Human Rights, Zeid Ra'ad Al Hussein and a meeting with the UN Working Group of Experts on People of African Descent. On World Water Day - March 22, 2017 - USHRN brought together an incredible group of Indigenous and Women of Color leaders based in the U.S., U.S.-occupied territories, and Tunisia for an official side event at the 61st United Nations Commission the Status of Women (CSW). Panelists discussed the climate crisis, economic empowerment, and the human right to water from the perspective of Southern, Black, Indigenous and Global South communities. During the official U.S. Country Visit of the UN Special Rapporteur on Extreme Poverty and Human Rights in December 2017, USHRN and members of civil society who testified to human rights violations and recommendations for implementation of human rights in the areas of Rural Women, Migrants & Refugees, and Indigenous Peoples.

The Midwest Regional Member Meeting was held in Flint, Michigan in July 2017. This meeting brought together members working across different issue areas and with different constituencies to meet each other and be
