CALIFORNIA IMMIGRANT RESILIENCE FUND (CIRF)IN RESPONSE TO THE COVID-19 PUBLIC HEALTH CRISIS, GCIR LAUNCHED CIRF IN MARCH 2020 TO PROVIDE EMERGENCY RELIEF TO UNDOCUMENTED IMMIGRANTS WHO WERE EXPERIENCING EXTREME ECONOMIC HARDSHIP AS A RESULT OF THE PANDEMIC BUT WERE INELIGIBLE FOR FEDERAL RELIEF AND UNEMPLOYMENT INSURANCE. THE ORGANIZATION RAISED OVER \$50 MILLION FROM OVER 70 INSTITUTIONAL FUNDERS, NEARLY 40 MAJOR DONORS, AND MORE THAN 800 INDIVIDUAL ONLINE DONORS, AND WORKED WITH 61 LOCAL PARTNER ORGANIZATIONS TO PROVIDE ONE-TIME EMERGENCY CASH ASSISTANCE TO HOUSEHOLDS ACROSS THE STATE. THE TIDES FOUNDATION WAS THE FISCAL MANAGER FOR THIS FUND, AND WHILE THE MAJORITY OF THESE FUNDS WERE CHanneLED THROUGH THEM, THERE WAS ROUGHLY \$8 MILLION THAT CAME DIRECTLY TO GCIR DUE TO EXISTING RELATIONSHIPS AND FUNDER PREFERENCES.
