AAMX ALSO HAS STRATEGIC ALLIANCES WITH VARIOUS CIVIL SOCIETY ORGANIZATIONS, INTERNATIONAL AGENCIES, AND GOVERNMENT INSTITUTIONS. WE ACTIVELY PARTICIPATE IN COORDINATION MECHANISMS WITH AUTHORITIES. WE HAVE THE REQUIRED EXPERIENCE AND KNOW-HOW TO ELABORATE RECOMMENDATIONS FOR GOOD PRACTICES, AND TO PROMOTE THE DEVELOPMENT OF INNOVATIVE METHODOLOGIES TO MODERNIZE AND UPDATE THE PROCESSES AND PROTOCOLS OF GOVERNMENT AUTHORITIES IN MATTERS OF INTERNATIONAL PROTECTION FOR FORCIBLY DISPLACED COMMUNITIES.
