This caused many local and national governments, including New York State, to impose restrictions on business operations, travel and public gatherings. The outbreak has adversely impacted the level of economic activity around the world and disrupted normal business activity in every sector of the economy. To help mitigate the dramatic impact that COVID-19 had on Single Stop's operations and financial viability, the organization took part in several governmental programs. In April 20, 2020, Single Stop was granted a PPP loan in the aggregate amount of \$329,967, pursuant to the Small Business Administration Paycheck Protection Program (the "SBA PPP") under the CARES Act, which was enacted March 27, 2020. The PPP Loan bears interest at a rate of 1% per annum, payable monthly commencing on November 1, 2020. Funds from the Loan may only be used for payroll costs, costs used to continue group health care benefits, mortgage payments, rent, and utilities. Single Stop used the entire Loan amount for qualifying expenses. Under the terms of the SBA PPP, certain amounts of the Loan may be forgiven if they are used for qualifying expenses as described in the CARES Act.
