THE BAYKEEPER BOAT PROGRAM OPERATES A BOAT THAT PATROLS THE WATERS OF THE NY/NJ HARBOR FOR VIOLATIONS AND ALSO ASSISTS WITH COASTAL RESTORATION OPERATIONS. IT ALSO OPERATES TWO PUMP-OUT BOATS THAT PUMP OUT SEWAGE FROM THE HOLDING TANKS OF RECREATIONAL BOATS AND TRANSPORTS IT TO SEWAGE TREATMENT FACILITIES TO IMPROVE WATER QUALITY. ONE PUMP-OUT SERVICES BOATERS IN RARITAN BAY, BUT IT DID NOT OPERATE IN 2021 DUE TO COVID CONDITIONS. THE OTHER PUMP-OUT BOAT IS OPERATED BY BAYKEEPER FOR MONMOUTH COUNTY ALONG THE NAVESINK RIVER, AND THAT BOAT WAS IN OPERATION DURING 2021.
