THIS PROGRAM IS DESIGNED FOR YOUTH AND YOUNG ADULTS (12 TO 25 YEARS OLD) WHO HAVE BEEN IDENTIFIED WITH SUBSTANCE USE AND IN SOME CASES, MENTAL HEALTH CONCERNS. THE COUNCIL WAS AWARDED A THREE-YEAR GRANT FOR THIS PROGRAM THAT BEGAN ON SEPTEMBER 30, 2019.DRUG-FREE COMMUNITY COALITIONS ARE FORMAL COLLABORATIVE ARRANGEMENTS AMONG GROUPS OR ORGANIZATIONS WITHIN A COMMUNITY THAT ARE FORMED OR EXPANDED TO PREVENT AND REDUCE YOUTH SUBSTANCE USE, INCLUDING PRESCRIPTION DRUG ABUSE, WITHIN THE COMMUNITY. IN A COMMUNITY COALITION, EACH MEMBER MAINTAINS ITS INDEPENDENT STATUS WHILE AGREEING TO WORK COLLABORATIVELY TO ACHIEVE A COMMON GOAL.

IN ORDER TO ESTABLISH A BASIS FOR MAKING RECOMMENDATIONS, THE COMMITTEE: REVIEWS THE FINANCIAL STATUS OF THE AGENCY, REVIEWS INDIVIDUAL SALARY RANGES TO DETERMINE IF RANGES ARE COMPETITIVE WITH SIMILAR JOBS IN SIMILAR AGENCIES, RESEARCHES THE CONSUMER PRICE INDEX (CPI) FOR THE PHILADELPHIA REGION FOR THE PAST SIX MONTHS, AND REVIEWS PERFORMANCE EVALUATIONS. ONCE ALL INFORMATION HAS BEEN REVIEWED, THE PERSONNEL COMMITTEE MAKES A RECOMMENDATION TO THE FULL BOARD OF DIRECTORS FOR REVIEW AND APPROVAL. THE BOARD'S APPROVAL IS DOCUMENTED IN THE MINUTES.
