THIS PROGRAM IS DESIGNED FOR YOUTH AND YOUNG ADULTS (12 TO 25 YEARS OLD) WHO HAVE BEEN IDENTIFIED WITH SUBSTANCE USE AND IN SOME CASES, MENTAL HEALTH CONCERNS. THE CORE CONCEPT OF THIS PROGRAM IS TO CREATE A SAFE SPACE WHERE THESE CHALLENGES ARE ADDRESSED, WITH AN EMPHASIS ON COGNITIVE BEHAVIORAL THERAPY (CBT) WHICH FOCUSES ON CHALLENGING AND CHANGING UNHELPFUL COGNITIVE DISTORTIONS AND BEHAVIORS, IMPROVING EMOTIONAL REGULATIONS AND THE DEVELOPMENT OF PERSONAL COPING STRATEGIES THAT TARGET SOLVING CURRENT PROBLEMS AND ON FAMILY ENGAGEMENT. THE COUNCIL WAS AWARDED A THREE-YEAR GRANT FOR THIS PROGRAM THAT BEGAN ON SEPTEMBER 30, 2019. DRUG-FREE COMMUNITY COALITIONS ARE FORMAL COLLABORATIVE ARRANGEMENTS AMONG GROUPS OR ORGANIZATIONS WITHIN A COMMUNITY THAT ARE FORMED OR EXPANDED TO PREVENT AND REDUCE YOUTH SUBSTANCE USE, INCLUDING PRESCRIPTION DRUG ABUSE, WITHIN THE COMMUNITY. IN A COMMUNITY COALITION, EACH MEMBER MAINTAINS ITS INDEPENDENT STATUS WHILE AGREEING TO WORK COLLABORATIVELY TO ACHIEVE A COMMON GOAL.
