PENNSYLVANIA RECOVERY ORGANIZATION - ACHIEVING COMMUNITY TOGETHER (PRO-ACT) IS A GRASSROOTS ADVOCACY AND RECOVERY SUPPORT INITIATIVE OF THE COUNCIL COVERING SOUTHEASTERN PENNSYLVANIA. PRO-ACT WORKS TO REDUCE THE STIGMA OF SUBSTANCE USE DISORDER, ENSURE THE AVAILABILITY OF ADEQUATE TREATMENT AND RECOVERY SUPPORT SERVICES, AND TO INFLUENCE PUBLIC OPINION AND POLICY REGARDING THE VALUE OF RECOVERY.(CONTINUED ON SCHEDULE O.)PROGRAMS INCLUDE: WARM HANDOFF IN 7 HOSPITALS ACROSS MULTIPLE COUNTIES SERVING 2,107 INDIVIDUALS, WITH 76% OF PATIENTS ACCEPTING RESOURCES OR TRANSFERRING FROM THE HOSPITAL DIRECTLY TO TREATMENT. COUNSELORS ARE DEDICATED TO PROVIDING QUALITY SERVICES TO MEET THE INDIVIDUAL NEEDS OF EACH DISTRICT AND THEIR STUDENTS; THE TEAM SUPPORTED 2,394 STUDENT REFERRALS, SCREENED 309 STUDENTS AND ASSESSED 298 STUDENTS.
