AN IN-PERSON CONVENTION LASTS SEVERAL DAYS AND INCLUDES HUNDREDS OF SCHOLARLY PRESENTATIONS RELATED TO PRACTICE, TRAINING, AND RESEARCH. NUMEROUS WORKSHOPS ARE AVAILABLE FOR CONTINUING PROFESSIONAL DEVELOPMENT. THE CONVENTION INCLUDES KEYNOTE AND FEATURED PRESENTATIONS ON TIMELY TOPICS. ADVOCACY: PROMOTES AND ADVOCATES FOR THE VALUE OF SCHOOL PSYCHOLOGICAL SERVICES AND FOR APPROPRIATE RESEARCH-BASED EDUCATION AND MENTAL HEALTH SERVICES FOR ALL CHILDREN, YOUTH, FAMILIES AND SCHOOLS.
