REGIONAL MEETING ARE HELD IN CONJUNCTION WITH THE ANNUAL CONVENTION AND ARE ATTENDED BY THE STATE DELEGATES, STATE ASSOCIATION PRESIDENTS, AND THE REGIONS' INVITEES.
