Education Equity: Our Education Equity Team has been one of the most successful advocates in driving the state to ensure all students obtain a high-quality education, from landmark civil rights lawsuits on school funding and teacher quality to shaping the Local Control Funding Formula (LCFF), which provides schools targeted funding to increase and improve services for some 3.5 million low-income students, English learners, and foster youth; the Local Control Accountability Plan (LCAP); the California School Dashboard; and the Cradle-to-Career data system for tracking student progress from pre-K through college and career. In 2020-21, we strengthened and enforced the LCFF's equitable funding, transparency, and community engagement requirements and won historic investments in racially-just, relationship-centered community schools (\$3 billion), (continued at Schedule O)

Metropolitan Equity: Our Metropolitan Equity Team advocates for equitable development, affordable housing, tenant protections, increased local transit service, and policies to break down patterns of segregation and inequitable allocation of public and private resources. In fiscal year 2020-21, we built and expanded regional and statewide networks that connect grassroots and advocacy organizations and elevate the voices of low-income Californians and communities of color in local, regional, and state policy. With our partners and allies, we successfully advocated for eviction moratoria that protected renters impacted by the pandemic from eviction and crippling debt. Form 990, Part III - Education Equity	Cont'd from page 2: teacher quality (\$2.9 billion), ongoing funding for staffing increases in schools with concentrations of high-need students, and student well-being. We helped write statutory language that closes a loophole that has allowed school districts to rollover unspent funds for high-need students into unrestricted general funds and deprived these students of billions of dollars in programs and services, and we successfully supported legislation to address the state's teacher shortage and increase teacher diversity. The California Department of Education agreed with our complaints against the Los Angeles Unified School District over its improper accounting and reporting practices for funding for high-need students and failure to meet requirements for community engagement, and the San Bernardino County Office of Education for unlawfully approving LCAPs that allowed districts to carry over unspent state funds for high-need students into their unrestricted general operating budgets in subsequent years and, in some cases, use these funds for school policing. Our Higher Education Team collaborated on a report documenting shortcomings in the implementation of California's community college remedial education reform law, AB 705, which requires community colleges to replace non-credit bearing remedial courses, which often have proven a dead end for Black and Latinx students, with credit-bearing transfer-level courses with corequisite support. We submitted formal letters to community college districts and colleges calling for full compliance with the law and created a video and webinars to educate students on their rights. Our recommendations for the new Cradle-to-Career Data system were included in legislation allocating \$15 million to implement the system. Our Local Power Building Team supported parents, students, and community stakeholders in Los Angeles, Long Beach, Oakland, West Contra Costa, Sacramento, Pomona, and Salinas in their advocacy for the use of state funding and federal relief funds to provide programs and services for high-need students. Our partners' advocacy won expanded mental health and academic supports, improved multilingual communications, an end to school policing, initiatives to address Black student achievement gaps, and resources for a restorative and just return to school.
Form 990, Part III - Metropolitan Equity	Cont'd from page 2: including measures to promote equitable housing production and the conversion of existing market-rate housing into permanently affordable housing. We successfully strengthened California's affirmatively furthering fair housing law, AB 686, and the Surplus Land Act, which requires jurisdictions to prioritize the use of surplus land for affordable housing. We led development of principles for equitable housing production that have been endorsed by more than 50 equity, housing, and environment justice groups. At the regional level, we co-led advocacy to ensure that all cities and counties create a fair sharing of affordable housing and break down historic patterns of segregation. We co-led a campaign that pressed the Metropolitan Transportation Commission to make \$450 million in federal transit funds available to prevent layoffs and service cuts, and we successfully advocated with transit agencies for pandemic-related safety measures. In Oakland and Concord, we provided legal support to campaigns to press large developers for community benefits, including affordable housing, good jobs, and environmental protections. At the national level, the Alliance for Housing Justice (AHJ), which we co-convene, opposed the repeal of the Affirmatively Furthering Fair Housing Rule and advocated with the new administration to reinstate and strengthen the rule. AHJ created fact sheets on the CDC eviction moratorium in 20 languages and fair housing explainer videos have been viewed more than 1.5 million times. AHJ convenes the National Grassroots Table, which brings together national base-building networks and state coalitions and organizations to build alignment and advance national housing policy reform. In FY21, Public Advocates (as co-counsel, not lead) initiated one active litigation matter which is still open: Rivas v. BYLD 2 LLC. A lawsuit was filed against a landlord to correct inhumane living conditions. This matter involves enforcement of recent Oakland tenant protection laws that can help demonstrate to landlords and renters the power of those laws. It is also part of an effort to deploy legal and organizing tools in concert to address landlord abuse and habitability issues. It is too early in the case to forecast attorney fees that may be sought and recovered.
