For more than five decades, Public Advocates has challenged the systemic causes of poverty and racial discrimination by strengthening community voices in public policy and achieving tangible legal victories advancing education, housing, transportation equity, and climate justice. We spur change through collaboration with grassroots groups representing low-income communities, people of color and immigrants, combined with strategic policy reform, media advocacy, and litigation.

Our Metropolitan Equity Team advocates for equitable development, affordable housing, tenant protections, increased local transit service, and policies to break down patterns of segregation and the inequitable allocation of public and private resources. At the state level, we co-convened the Social Housing Coalition and the Stable Homes California coalition, which are advancing innovative, off-market solutions to create and preserve affordable housing. In Sacramento we successfully supported AB 721, which removes restrictions in covenants on density for affordable housing developments, and AB 215, which strengthens the state's enforcement of the Housing Element law and the public's right to meaningful opportunities to comment on local housing plans. In 2021-22, Public Advocates' Education Equity Team, with our partners and allies, won a \$1.1 billion state investment in racially just and relationship-centered community schools for a total investment of \$4.1 billion over the past two state budgets; a permanent 6.56 percent cost-of-living adjustment and a \$4.32 billion increase to the LCFF base grant; the equitable distribution of the nearly \$8 billion Learning Recovery Emergency Block Grant; and \$100 million to expand the Community Engagement Initiative, which Public Advocates won in 2018. Form 990, Part III - Education Equity	Cont'd from page 2: We successfully advocated to ensure the robust implementation of provisions we won in 2021 that close a loophole in the LCFF that allowed districts to rollover unused funds for high-need students into subsequent year general operating budgets, thus depriving these students billions of dollars in programs and services, and the \$1.1 billion in ongoing funding we helped win for staffing increases in districts with high concentrations of high-need students. In June 2022, California achieved a major milestone with the public release of data from the new California State Assignment Accountability System (CalSAAS) created by the Legislature after nearly 15 years of advocacy in which Public Advocates played a leading role. This data provides powerful leverage for ensuring the equitable assignment of prepared and qualified teachers. With our partners and allies we advocated to ensure that the implementation of the state's historic investments in community schools - which provide wrap-around academic, health, and social-emotional supports - centers the voices of low-income and Black, Indigenous, and people of color. We supported six regional forums where more than 600 parents, students, and community organizations elevated their needs, and we ensured that the Community Schools Framework reflected their priorities. We successfully advocated for a ban on the use of community school funds for law enforcement and punitive disciplinary practices. Our Local Power Building Team supported parents, students, and community stakeholders in school districts throughout the state in their advocacy for programs and services for high-need students, the creation and expansion of community schools, reforming school safety, and initiatives to address Black student achievement gaps. Our Higher Education Team continued to press for the full implementation of AB 705, which requires community colleges to replace non-credit bearing remedial courses with credit-bearing transfer-level courses with corequisite support, and we led successful advocacy for AB 1705, which closes loopholes in that law. The Higher Education team supported state budget investments that will add thousands more seats at the University of California and California State University, improve graduation rates, close racial equity gaps, increase institutional accountability, and address non-tuition expenses that impact the ability of low-income students and students of color to access postsecondary education.
Form 990, Part III - Metropolitan Equity	Cont'd from page 2: We also launched the Investment Justice Project to win access to new federal and state resources for projects and services prioritized by low-income residents, workers, and communities of color. In the Bay Area we supported local campaigns for strong Housing Element plans that meet the needs of low-income residents for affordable housing, address segregation and exclusionary zoning, and provide tenant protections. In Oakland, Berkeley, and San Jose we provided legal support to campaigns for Tenant/Community Opportunity to Purchase legislation that would allow tenants and nonprofits a first opportunity to purchase rental properties and preserve their affordability before they are put up for sale. We supported the Community Coalition for a Sustainable Concord, which is pressing Concord to honor its commitment to create 25 percent lower-income housing at the massive Concord Naval Weapons Station site; the Oakland United Coalition, which is advocating to ensure that community needs are incorporated into a proposed ballpark complex on public land and the redevelopment of the Coliseum site in East Oakland; and the Voices for Public Transit coalition, which advocates for worker and rider safety and the prevention of deep cuts to transit service at a time of pandemic and is advancing a regional transit funding measure. At the national level, the Alliance for Housing Justice (AHJ), which Public Advocates co-convenes, anchors the National Grassroots Table, which brings together national base-building networks and state coalitions to build alignment, advance national housing policy reform, and provide support and resources to build the capacity of grassroots organizing groups and state and regional housing justice tables. AHJ has engaged with the current administration to shape policies for affirmatively furthering fair housing, equitable zoning reform, and the distribution of federal resources to address the nation's housing crisis.
