THE COMMUNICATIONS DIRECTLY REACHED AT LEAST ONE MILLION PEOPLE WHO TOOK MORE THAN 7.5 MILLION ACTIONS IN THE 2022 FISCAL YEAR. THESE ACTIONS CONTRIBUTED TO ACCOMPLISHMENTS LIKE RESTORING PROTECTIONS FOR TONGASS NATIONAL FOREST, STOPPING A \$200 MILLION LOAN PACKAGE TO MARFRIG GLOBAL FOODS THAT WOULD HAVE INCREASED INDUSTRIAL AGRICULTURE AND HUMAN RIGHTS VIOLATIONS IN THE AMAZON, AND PUSHING PRESIDENT BIDEN TO BAN THE BRAIN-DAMAGING PESTICIDE CHLORPYRIFOS IN FOOD.
