OUTREACH AND MEMBERSHIP - THE OUTREACH PROGRAM EDUCATES MEMBERS AND ACTIVISTS AS WELL AS THE GREATER PUBLIC ABOUT SIGNIFICANT THREATS TO THE ENVIRONMENT, AND ENCOURAGES THEM TO PARTICIPATE WITH FRIENDS OF THE EARTH TO ACHIEVE POSITIVE OUTCOMES INCLUDING PROTECTING POLLINATORS FROM TOXIC PESTICIDES, PROTECTING PUBLIC LANDS FROM POLLUTION, AND PREVENTING INDUSTRIAL PROJECTS THAT WOULD HARM COMMUNITIES AND ECOSYSTEMS. THIS IS DONE THROUGH ONLINE ACTION ALERTS, ONLINE ADVERTISING, MAILINGS PRINT NEWSLETTERS (TO MEMBERS), AS WELL AS SOCIAL MEDIA SITES LIKE FACEBOOK, TWITTER, AND YOUTUBE. THE COMMUNICATIONS DIRECTLY REACHED OVER ONE MILLION PEOPLE WHO TOOK MORE THAN 7.2 MILLION ACTIONS IN THE 2023 FISCAL YEAR. THESE ACTIONS CONTRIBUTED TO ACCOMPLISHMENTS LIKE SUPPORTING LOCAL YUMAN-SPEAKING TRIBES IN THEIR FIGHT TO GAIN NATIONAL MONUMENT DESIGNATION FOR AVI KWA A ME IN NEVADA, BLOCKING THE DEVELOPMENT OF THE PEBBLE MINE PROJECT IN BRISTOL BAY, ALASKA, AND PASSING A BILL IN MARYLAND REQUIRING ANALYSIS OF THE HEALTH AND ENVIRONMENTAL IMPACTS OF PFAS CONTAMINATION IN PESTICIDES.
