OUTREACH AND MEMBERSHIP - THE OUTREACH PROGRAM EDUCATE MEMBERS AND ACTIVISTS AS WELL AS THE GREATER PUBLIC ABOUT SIGNIFICANT THREATS TO THE ENVIRONMENT, AND ENCOURAGES THEM TO PARTICIPATE WITH FRIENDS OF THE EARTH TO ACHIEVE POSITIVE OUTCOMES INCLUDING PROTECTING POLLINATORS FROM TOXIC PESTICIDES, PROTECTING PUBLIC LANDS FROM POLLUTION, AND PREVENTING INDUSTRIAL PROJECTS THAT WOULD HARM COMMUNITIES AND ECOSYSTEMS. THIS IS DONE THROUGH ONLINE ACTION ALERTS, ONLINE ADVERTISING, MAILINGS INCLUDING PRINT NEWSLETTERS (TO MEMBERS), AS WELL AS COMMUNICATIONS ON SOCIAL MEDIA SITES LIKE FACEBOOK, X AND YOUTUBE. FOE ALSO SEEKS OPPORTUNITIES TO EDUCATE THE PUBLIC THROUGH TV AND RADIO INTERVIEWS. THE COMMUNICATIONS DIRECTLY REACHED OVER ONE MILLION PEOPLE WHO TOOK MORE THAN 6.3 MILLION ACTIONS IN THE 2024 FISCAL YEAR. THESE ACTIONS CONTRIBUTED TO ACCOMPLISHMENTS LIKE SECURING A PAUSE ON NEW LIQUIFIED NATURAL GAS EXPORT TERMINALS, PROTECTING WYOMING'S PUBLIC LANDS FROM FOSSIL FUEL DRILLING, AND PASSING THE BIRDS AND BEES PROTECTION ACT IN NEW YORK TO RESTRICT AGRICULTURAL USE OF TOXIC PESTICIDES.
