SOME OF THE DATA IS PUBLICLY AVAILABLE, BUT OTHER DATA REMAINS CONFIDENTIAL AND IS PRIVATELY OWNED. AWWIC IS THE MOST COMPREHENSIVE DATABASE OF POST-CONSTRUCTION FATALITY MONITORING DATA FROM U.S. WIND PROJECTS. AWWIC EXPANDS THE AVAILABILITY OF WIND-WILDLIFE DATA FOR SCIENTIFIC ANALYSIS BY WORKING WITH INDUSTRY COLLABORATORS TO INCORPORATE BOTH PUBLICLY AVAILABLE AND CONTRIBUTED DATA WHILE MAINTAINING CONFIDENTIALITY.BY USING BIG DATA, AWWIC AND NEW RISK MODELS ARE REDUCING UNCERTAINTY AND INFORMING DECISION-MAKING TO HELP IMPROVE CONSERVATION.
