DURING MEETINGS WITH POTENTIAL BOARD MEMBERS, THERE IS A DISCUSSION OF POTENTIAL CONFLICTS AND THE POTENTIAL IMPACT OF THE RELATIONSHIP BETWEEN TVCH AND THE BOARD MEMBER. IF THERE IS A CONFLICT OF INTEREST, THE POTENTIAL BOARD MEMBER WILL NOT JOIN THE BOARD. PROGRAMMATICALLY, MANAGERS ARE NOT ALLOWED TO SUPERVISE FAMILY/FRIENDS. CASE MEMBERS ARE NOT ALLOWED TO PROVIDE SERVICE TO INDIVIDUALS WHERE A RELATIONSHIP HAS BEEN ESTABLISHED PRIOR TO TVCH.
