FORM 990, PART VI, SECTION A, LINE 7B	THE STEERING COMMITTEE SHALL HAVE THE POWER TO AMEND THIS CONSTITUTION, BUT ONLY WITH THE CONSENT OF BOTH THE FOUNDING UNIONS.
