Get Married Initiative (GMI) GMI publishes original social science research and analysis on the state of marriage and how the family impacts individual and societal wellbeing. GMI produces research reports and briefs and provides expert commentary across a variety of live settings in media and legislatures.

Family First Technology Initiative (FFTI) FFTI produces original research and policy analysis on the impact of technology, social media, and artificial intelligence on family life in general and children in particular. FFTI drafts model legislation and is a leading public voice examining and evaluating tech regulation and debates across the country. Our research and analysis have shaped more than a dozen state laws concerning online child safety and FFTI fellows are featured regularly in media and appear in person as experts on these issues.

Public Engagement Initiative IFS reaches the general public with research and analysis through its website, earned media placements, and social media channels. During the fiscal year, our research and fellows were cited or featured in over 1,000 outlets including The New York Times, The Wall Street Journal, The Washington Post, Forbes, the Financial Times, Fox News, NPR, and TIME. Website traffic doubled year over year. Fellows contributed commentary such as op-eds to national publications and testified before state legislatures on marriage, family formation, young adult success, and technology policy.

Pronatalism Initiative (PI) PI conducts original research as well as rigorous analysis of existing data to understand fertility trends and the causes of domestic and international below-replacement birth rates. The research has direct application for policy makers and has impact through regular media and press coverage educating the general public on the importance of fertility rates.
