SAFETY NETIN 2021, WE BEGAN TO TRANSFORM THE SOCIAL SAFETY NET BY UTILIZING THE TOOLS OF HUMAN - CENTERED TECHNOLOGY, MODERNIZING BENEFIT SYSTEMS BY PERMANENTLY ADDRESSING BARRIERS TO ENROLLMENT, USAGE AND RETENTION. SPECIFICALLY WE HELPED 2.8 MILLION PEOPLE ACCESS FOOD AND OTHER BENEFITS EASILY AND WITH DIGNITY, WHILE LAYING THE GROUNDWORK FOR EXPANDING OUR SOCIAL SAFETY NET WORK NATIONALLY.
