ANY BOARD OF DIRECTORS SHALL NOT APPROVE ANY TRANSACTION WHICH INVOLVES A POTENTIAL CONFLICT OF INTEREST WITH A DIRECTOR UNLESS AND UNTIL THE BOARD OF DIRECTORS HAS SPECIFICALLY AND IN GOOD FAITH DETERMINED AFTER REASONABLE INVESTIGATION (INCLUDING A REVIEW OF THE TERMS UPON WHICH OTHER COMPARABLE ORGANIZATIONS ENTER TRANSACTIONS OR ARRANGEMENTS SIMILAR TO THE ONE UNDER CONSIDERATION) THAT: A. THE BOARD IS AWARE OF ALL MATERIAL FACTS CONCERNING THE TRANSACTION AND THE DIRECTOR OR OFFICER'S INTEREST IN THE TRANSACTION; B. NSCRC IS ENTERING INTO THE TRANSACTION FOR ITS OWN BENEFIT; C. THE TRANSACTION IS FAIR AND REASONABLE AS TO NSCRC; AND D. NSCRC COULD NOT HAVE OBTAINED A MORE ADVANTAGEOUS ARRANGEMENT WITH REASONABLE EFFORT UNDER THE CIRCUMSTANCES. MANAGEMENT SHALL BE RESPONSIBLE FOR PROVIDING THE BOARD WITH SUFFICIENT INFORMATION SO THAT THE BOARD CAN ASSESS THE FAIRNESS AND REASONABLENESS OF THE COMPENSATION INVOLVED. NSCRC MUST CONDUCT PERIODIC REVIEWS TO ENSURE THAT ALL COMPENSATION ARRANGEMENTS, PARTNERSHIPS, JOINT VENTURES, AND OTHER TRANSACTIONS INVOLVING DIRECTORS AND OFFICERS ARE REASONABLE, REFLECT ARMS LENGTH BARGAINING, AND FURTHER CHARITABLE PURPOSES, AND DO NOT RESULT IN UNREASONABLE BENEFIT TO THE DIRECTOR OR OFFICERS OR ANY OTHER PRIVATE SHAREHOLDER OR INDIVIDUAL. WHEN CONDUCTING THESE REVIEWS, NSCRC MAY, BUT NEED NOT, USE OUTSIDE ADVISORS. ANY USE OF OUTSIDE ADVISORS, HOWEVER, SHALL NOT RELIEVE THE BOARD OF DIRECTORS OF ITS RESPONSIBILITY FOR CONDUCTING THE PERIODIC REVIEWS. A COPY OF THIS POLICY MUST BE FURNISHED TO ALL INCUMBENT AND INCOMING DIRECTORS AND OFFICERS OF NSCRC ON AN ANNUAL BASIS. EACH DIRECTOR AND OFFICER SHALL ANNUALLY SIGN A STATEMENT THAT AFFIRMS THAT HE OR SHE HAS RECEIVED A COPY OF THIS POLICY, HAS READ AND UNDERSTANDS THE POLICY, AND HAS AGREED TO COMPLY WITH THIS POLICY, IN ADDITION TO A COPY OF THE ATTACHED DISCLOSURE FORM AND A CURRENT COPY OF THE DIRECTOR'S RESUME TO THE EXECUTIVE DIRECTOR OF NSCRC.

THE ASSESSMENTS INCLUDED THOSE EMPLOYEES PERFORMING SERVICES FOR NSCRC. THE BOARD OF NSC APPROVES THE COMPENSATION OF THE CEO AND OTHER OFFICERS. DELIBERATIONS AND DECISIONS ARE DOCUMENTED CONTEMPORANEOUSLY IN THE MINUTES OF THE BOARD OF DIRECTORS. A GROUP OF INDEPENDENT PERSONS WHO SERVE ON THE BOARD OF DIRECTORS EVALUATE EXTERNAL COMPENSATION DATA FROM COMPARABLE INSTITUTIONS, DISCUSS THEIR REVIEW, AND CONTEMPORANEOUSLY DOCUMENT THEIR CONCLUSION THAT THE TOTAL COMPENSATION PAID TO SUCH PERSONS IS REASONABLE.
