ACTIVITIES INCLUDE NARRATIVE CHANGE WORK, PUBLIC AWARENESS AND CORPORATE ACCOUNTABILITY CAMPAIGNS, AND COALITION-BUILDING.AFTER ESTABLISHING POLICIES, PROCEDURES, AND STAFFING THE PROGRAM, FAIRPLAY'S YOUNG CHILDREN THRIVE OFFLINE PROGRAM CONDUCTED RESEARCH AND PUBLISHED A WHITE PAPER, "HOOKED FROM BIRTH: PROMOTING STRUCTURAL CHANGE AND AVOIDING PARENTAL SHAME IN THE BATTLE TO REDUCE EARLY CHILDHOOD SCREEN TIME," ALONG WITH A MESSAGING GUIDE FOR PARTNERS.
